### **Analytics Data:**

- Website usage patterns
- Popular content and pages
- User journey through the Website
- Search terms used to find our Website
- Download and form completion rates

# 3. Cookies and Tracking Technologies

#### 3.1 What Are Cookies?

Cookies are small text files that are placed on your device (computer, smartphone, or tablet) when you visit our Website. They are widely used to make websites work more efficiently and provide information to website owners.

#### **Types of Cookies We Use**

- Session Cookies: These are temporary cookies that expire when you close your browser
- Persistent Cookies: These remain on your device for a set period or until you delete them
- First-Party Cookies: These are set directly by our Website
- Third-Party Cookies: These are set by external services we use on our Website

### 3.2 How We Use Cookies

We use cookies for the following purposes:

## **Essential Cookies (Strictly Necessary)**

These cookies are essential for the Website to function properly. They enable core functionality such as:

- Identifying popular features and content
- Understanding visitor behaviour patterns
- Monitoring error rates and technical issues
- Conversion tracking for demo requests and downloads

#### **Information Collected:**

- Pages visited and time spent
- Click-through rates and interactions
- Browser type and device information
- Referring websites and search terms
- Geographic location (country/region level)
- Download and form completion rates

**Legal Basis:** Legitimate interest in improving our Website and services **Retention Period:** Up to 26 months (anonymized after 14 months)

#### **Marketing Cookies**

These cookies are used for marketing and advertising purposes:

- Tracking lead generation and conversion
- Personalizing marketing messages
- Measuring advertising effectiveness
- Retargeting website visitors
- Social media integration and tracking

**Legal Basis:** Consent (you can withdraw consent at any time)

Retention Period: Up to 12 months
